### SECTION - I

#### **NOTICE INVITING E-TENDERS THROUGH E-PROCUREMENT**

1.1 E-tenders are invited from the experienced and eligible service providers for hiring of one Non AC Car (mid segment CNG fuel based sedan car like viz. Dzire/Xcent/Indigo/Etios/ etc.) for use by the Office of Commissioner, Directorate of Logistics, Customs and Central Excise, 4<sup>th</sup> Floor, 'A'-Wing, Lok Nayak Bhavan, Khan Market, New Delhi 110511. Interested parties, who meet the qualification criteria laid down in Section II, are to submit their bids as per two bid system i.e. Technical and Financial bid separately as per Annexure – 'I' and Annexure – 'II' of Section II.

1.5 Earnest Money Deposit (EMD) of Rs. 15,000/- (Rupees Fifteen Thousand Only) and a non-refundable Tender fee of Rs. 500/- (Rupees five Hundred only) in the form of account payee demand draft / bankers cheque, drawn on a scheduled commercial bank in India, in favour of "PAO, O/o the Pr. C.C.A., C.B.E.C." payable at New Delhi valid for a period of at least 2 months from the date of opening of tender must reach at the address given above by 1300 hours on 16.03.2017. Tenderers, however, have to attach scanned copies of EMD & Tender fee along with the Technical bid of their e-tender.
