2.2 The bidder will quote price separately for each category as per the proforma given below –

- 2.3 A bidder, if wants, can quote for one or both the categories. However, the auction will be carried out/sold out with full quantity of condemned material in that category and not in pieces. Amount shall be quoted for each category as a whole.
- 2.4 All the bids will be received in a sealed envelope at a given date & time above. The bidder submitting bids for both the categories, can submit the same in one sealed envelope only.
- 2.5 After opening the bids at a date & time given above, the Price Evaluation will be made separately for each category to ascertain the highest bidder (H1). Based on the price evaluation, the award shall also be given separately to the highest bidders in each category.
- 2.6 No items, once disposed to the higher bidder shall be taken back by the Directorate of Logistics under any circumstances whatsoever.
- 2.7 The highest bidders in both the categories, will be required to deposit at least 25% of the bid value by 1700 hrs on 17.12.2019 (the day of auction) by cash or Demand Draft/Pay order issued by any Commercial bank. The DD/Pay order shall be drawn in favour of "The Pay & Accounts officer, CBEC, New Delhi payable at New Delhi". The prospective bidder will be required to produce a copy of identity proof of self/residential address before opening of the bids.
- 2.8 The highest bidders will make the balance payment of 75%, in the form of Demand Draft/Pay order issued by any Commercial Bank by 1200 hrs. on 18.12.2019, failing which the offer will be cancelled and 25% of amount deposited shall stand forfeited. This DD/Pay order shall be drawn in favour of "The Pay & Accounts officer, CBEC, New Delhi payable at New Delhi"
- 2.9 The highest bidders will be required to lift all the items from the disposal site within 2 days i. e. by 1700 hrs on 20.12.2019 after the payment of the full amount.
- 2.10 The highest bidders should ensure that the whole auctioned lot is removed and in case any item left at site, the same shall be thrown away at the risk and cost of highest bidder.
- 2.11 The labour, cartage and other expenses shall be borne by the highest bidders.
- 2.12 The terms & conditions are not exhaustive but general in nature. Directorate of Logistics shall have the right to clarify any clause or part thereof the terms & conditions and that will be final and binding.
- 2.13 The auction can be rescheduled / cancelled as per the discretion of the Directorate of logistics.
