NOTIFICATION

G.S.R. No. 662... In exercise of the powers conferred by the provision to article 309 of the constitution and in supersession of the Marine establishment (Customs and Central Excise Departments) (Group 'C' and 'D' posts) Recruitment Rules, 1986 and the Customs Marine Division (Group 'C' and Group 'D') Technical posts Recruitment Rules 1986 (excluding the posts of Seaman Gr. II and Driver) in so far as they relate to the posts Skipper Mate, Foreman of Stores, Engineer Mate, Artisan, Senior Storekeeper, Draftsman, Tindal, Engine Drivers, Draftsman, Storekeeper, Launch Mechanic, Sukhani, Senior Deck Hand, Asstt. Storekeeper, Trademan, Seaman, Greaser, Lascar, Unskilled Industrial Worker (UIW) except as respects things done or omitted to be done before such supersession the president hereby makes the following rules regulating the method of recruitment to Group 'C' and 'D' posts in the Marine Organisation of Customs and Central Excise Department.

1. Short title and commencement.

These rules may be called the Marine Organisation of Customs and Central Excise Department (Group 'C' and 'D' posts) Recruitment Rules, 1994.

They shall come into force on the date of their publication in the official Gazette.

2. Application:- These rules shall apply to the posts specified in column 1 of the Scheduled annexed to these rules.

3. Number of posts, classification and scale of pay :- The number of the said posts their classification and the scales of pay attached there to shall be as specified in columns 3 to 5 of the said schedule.

4. Method of Recruitment, age limit other qualification etc. :- The method of recruitment, age limits, qualification and other matters relating to the said post shall be as specified in columns 6 to 15 of the said schedule.

5. **Initial constitution:** - The incumbents of the posts shown in the schedule, who were recruited /appointed on a regular basis before the commencement of these rules shall be deemed to have been appointed under these rules. The service rendered by them in a post on regular basis shall be taken into account for, deciding the eligibility for promotion to the next higher post.

6. **Disqualification:**- No person,

- (a) Who has entered into or contracted a marriage with a person having a spouse living or
- (b) Who, having a spouse living has entered into or contracted a marriage with any person, shall be eligible for appointment to any of the said posts.

Provided that the Central Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, may exempt a person from the operation of this rules.

7. **Power to relax:**- Where the Central Government is of the opinion that it is necessary or expedient to do so, it may, by order, for reasons to be recorded in writing, relax any of the provisions of these rules with respect to any class or category of persons.

8. **Saving:** - Nothing in these rules shall effect reservations, relaxation of age-limit and other concessions required to be provided for the scheduled castes, the Scheduled Tribes, Ex-Serviceman and other special Categories of persons in accordance with the orders issued by the Central Government from time to time in this regard.
