2. Commissioner (Logistics) welcomed all the participants and conference started with the brief introduction by all the participants. Queries received through On-line were required to be answered in the conference. It has been informed to the participants that only four clarifications have been found to have been uploaded online on www.eprocure.gov.in till 1500hrs on 09.03.2015.

- 3. The pre-bid queries were opened on 9.3.2015. There were four queries found in the portal. It is found that out of these four queries three have stated to have attached the files. However only one file in respect of M/s NDTS was found attached. Further, there is no attachment or clarifications sought by the bidders were found attached in respect of other two. However, M/s Karl Storz Endoscopy India Pvt Ltd, New Delhi submitted their queries through email dated 10.3.2015. M/s NDTS, Navi Mumbai submitted their on query and uploaded on the portal through mail dated 12.3.2015. The names of the bidders, in respect of other two parties were not available in their queries.
